WELCOME FROM THE CHAIR

HOURY GEUDELEKIAN, NGO CSW/NY CHAIR

As I reflect on my final year as chair of NGO CSW/NY, which organizes the forum parallel to the annual UN Commission on the Status of Women, I wonder. How did I get here?

Let me take you back to a beautiful February day in 2011, when I had a coveted CSW55 UN ground pass, thanks to the Armenian Relief Society. A friend heard I was divorced and needed a new adventure, so she hooked me up with the leadership of the Armenian group, suggesting “Houry is a New Yorker and can get things done for you.” Little did they know I needed this gig as a lifeline and little did I know it was going to be one of the biggest lessons of my life (starting with the endless UN acronyms). I walked around the crowded halls of the UN at the 55th CSW, attending its side events and exploring the civil society parallel events at the Church Center across the street, where advocates met to share their experiences in improving gender equality globally. I was lucky enough to meet women from the NGO Committee on the Status of Women (NGO CSW/NY) and witnessed the launch of UN Women where the first executive director Michelle Bachelet, a former president of Chile, spoke to me directly. She talked about providing women and girls better health and education, economic empowerment, and protection from violence. I could relate to all of it personally.

I am an Armenian born in Beirut. My grandparents survived a genocide; my parents endured 20 years of Lebanese civil war. At the age of 15, already married, my husband and I immigrated to New York City in 1976, where all I wanted was to finish high school and dance at Studio 54. Miraculously, I was able to get a high school equivalency diploma within six months, dance (a lot), and eventually a few years later, own a beauty business with my husband for 35 years. As proud as I am of what we accomplished together, raising three amazing feminist sons and living a lavish New York lifestyle, I knew I had to somehow find my own voice that I buried at the age of 14. That is what brought me to CSW55, divorced and almost 50 years old.

Even with all my accomplishments, I could relate to every challenge that UN Women promised to work through the UN system to achieve gender equality. I was in. I became the part-time UN Coordinator of the Armenian Relief Society, working 60 to 70 hours a week, learning more than any official education could teach me.

The NGO CSW/NY became my second home for the next 12 years with one small interlude when I had a mini-breakdown and had to quit both the ARS and NGOCSW/NY. The emotional meltdown was prompted by colleagues I loved and trusted, but who demeaned me and my contributions. What brought me back within a few months was watching a young member stand up for herself. I was grateful for that experience, which prompted me to stand up for myself and those around me who were also getting hurt. The reality that some feminists and women's rights activists continue to adopt patriarchal attitudes of dominance and privilege in our own space was completely new to me. It hurt even more because I had so much respect for these inspiring women working and sharing their expertise as part of the movement.

Back in 1995, while I was at the height of my career as a public relations expert and nursing my marriage, global women's rights activists achieved an unprecedented agreement with 189 countries to introduce the Beijing Platform for Action's 12 critical areas of concern. To this day, it is the defining document that also drives CSW. While we work with the UN Member States to help implement the Beijing declaration, we are also supporting creative ideas that can bring faster and more targeted achievements. One example is the Generation Equality Forums processes, held in Mexico City and Paris in 2021 and meant to drive gender equality to the finish line. I was tasked by UN Women to be the civil society convenor, helping organize the two Forums that took a multi-stakeholder approach parallel to the UN process. Despite the slowdowns from the pandemic and push back from all sectors of society, the campaign remains an opportunity to deliver gender equality through its Action Coalitions such as gender-based violence, economic justice, reproductive health, climate justice, technology, feminist movement, peace/security and global alliance for care.

Yet the truth is the women's movement itself needs much healing and reflection not to uphold the patriarchal attitudes we are trying to overcome and dismantle. If we don't take care of ourselves individually, we bring the pain into our work, social life, and families. I see a clear line between the individual and the world. A peaceful mind and body can bring peaceful solutions. Violent perpetrators are often in pain themselves, they need help to heal themselves.

In my own journey of healing with therapy, meditation, and yoga, I learned of Ahimsa, which is respect for all living things and avoidance of violence toward others. We must all keep striving to protect ourselves, our planet and all living beings.

As challenging as this might seem in a political space such as the UN, we are trying to bring this mentality to the Commission on the Status of Women space. In the last few years, despite more pushbacks, we are experiencing shifts I never imagined; a kind of change that inspires me to get up every day and try harder.

During the last four years, we at NGO-CSW have quadrupled our followers and influence, largely because of the shift to virtual participation. That transition has made it possible for thousands of more people to attend the 11-day forum without having to travel to the UN headquarters.

In March 2020, we had to cancel the 64th session of the CSW due to Covid-19. We went fully virtual the next year, hosting over 27,000 global participants and holding 700-plus parallel events on our virtual portal. With this year's new hybrid model, CSW67 will be focusing on Innovation and technological change, and education in the digital age. It will take more than a village to pull this off from March 5 to 17.

My team at the NGO CSW/NY are determined to make this the year that challenges the status quo. The partnerships and the collaborations we are bringing together through a transparent, shared leadership model is the start of a more creative and supportive way to present our demands to improve the lives of women and girls in all their diversity. Join us in person or virtually for the 67th session to learn, engage and help us all achieve the goals set forth by Beijing Platform.

Something I learned from our African sisters, Ubuntu, meaning humanity or more importantly: I am because we are, resonates deeply in me.

VIRTUAL SAFETY GUIDELINES



NGO CSW/NY is committed to ensuring that everyone has a fulfilling experience with the NGO CSW65 Virtual Forum. Our goal is to make the Forum as inclusive and productive as possible through a shared leadership model. Below are some guidelines for successfully utilizing the virtual platform, as well as principles to follow to assure a safe environment founded in respect and inclusivity.

- Use welcoming and inclusive language.
- Commit to open dialogue and transparency. Remain driven by our collective mission of advancing gender equality, feminism and women's rights. Build a culture of excellence, compassion, integrity, and honesty.
- Respect one another. Listen, avoid assumptions, enable different opinions. Critique ideas, not people.
- Allow everyone to participate. Don't dominate the conversation and honor time limits.
- Show empathy toward other participants.
- Respect the diversity of languages, opinions and expertise, while acknowledging that sexism, racism, classism, heterosexism, transphobia, global North domination and other institutionalized forms of oppression exist.
- Honor confidentiality and "I" statements ("I" instead of "they," "we," or "you"). Speak from your own experience instead of generalizing.
- Be positive and seek unity. Build people's ideas up rather than knocking them down, and refrain from personal attacks.
- This is a space where the voices of the marginalized are amplified and given "expert" priority when recounting their own experiences. Their experiences of oppression are not up for debate or to be refuted in any way.
- This is an antiracist space meaning that we welcome, value and revere an intersectional approach to feminism. An anti-racist space requires that all of us need to consider our positionality and work actively not to replicate white patriarchal structures including subjugating voices of Black women and women of color.

NGO CSW/NY will not tolerate harassment of any kind including but not limited to:

- Offensive comments related to gender, gender identity and expression, sexual orientation, disability, mental illness, physical appearance, political affiliation, age, race, national and/or ethnic origin, immigration status, language, religion, or indigeneity.
- Deliberate intimidation
- Sustained disruption of discussion
- Continued one-on-one communication after requests to cease.



It is my honour and privilege to welcome the Non-Governmental Organisations (NGO) Community to the Sixty-Seventh Session of the Commission on the Status of Women (CSW67). This year will mark my second and concluding year as the Chair of the CSW. I am pleased that during my tenure I enjoyed a productive and constructive working relationship with the NGO Community. Working with the Bureau, we continued the practice of fully engaging all stakeholders on the priority theme for CSW67 “Innovation and technological change, and education in the digital age for achieving gender equality and the empowerment of all women and girls”. I thank you for your contribution to the work of the Commission.

This year’s priority theme is represents a gateway to hold a proactive conversation on an important emerging sector. As women, we are in a position to ensure that a gender perspective is embedded into the design and creation of digital solutions that work for all. CSW67 will allow us to engage on a topic that has not firmly established its practices, and therefore presents the potential to shape a future where technology contributes to changing social norms, amplifying women’s voices, pushing back against online harassment, preventing the perpetuation of algorithmic biases, and distributing the benefits of digitalization equally in the pursuit of achieving the Sustainable Development Goals.

We should recognise that gender digital gap is rooted in stereotypes that have impacted on women’s participation and leadership in innovation processes. The under-representation of women in science and technology at a personal, environmental and school level, results in women rarely being viewed and empowered as creators, promoters and decision makers in their fields. This, in-turn, limits their ability to innovate and create technology that responds to the needs and priorities of women and girls.

Innovation ecosystems should advance gender equality, but it will require a multi-stakeholder approach. This needs to incorporate the capacities and expertise of companies and encourage academia to stimulate the development of digital solutions. Additionally, Governments and civil society organisations would need to interact more closely to inspire an enabling environment for women and girls.

The discussions at CSW67 will create the platform for increased participation of women and girls in the technology and innovation sector, whilst highlighting the value of science, technology, engineering and mathematics education for women and girls to enable access to these fields. The priority theme is holistic in its approach and seeks to firmly address the shortcomings that have already been exposed at this stage in the field before they are irreversible.

This cannot be done without the support and the role played by civil society. The Commission has been able to deliver on its mandate due to its multi-stakeholder character and the critical bridge that has been built between the civil society and the policy makers during each session – and it is expected that this session will be no different. I wish all civil society and non-governmental organisations all the best for a successful session and express my confidence in this committed group to champion the empowerment of women and girls and ensure a sustainable and prosperous future for all.

The 67th session of the Commission on the Status of Women (CSW67) takes place in a world suffering from multiple crises, stalled or reversed progress in the achievement of the Sustainable Development Goals and deepening misogyny in many quarters. The 'status of women' is under multiple threats. As the first in-person CSW since the outbreak of the COVID-19 pandemic three years ago, anticipated to have the largest presence of civil society on record, it offers a vital opportunity for collective consultation and progress.

CSW67's priority theme addresses how we might use the powerful levers of innovation and technology to effectively address the regressions we have witnessed in gender equality through the pandemic and its interlinked crises of climate and conflict. In particular, it directs us to examine and repair the damaging gap in access to digital spaces and skills for women and girls, the related limitations on learning and livelihoods, and the dangers of online violence augmenting those women face offline.

The future of technology must not result in a future of greater inequality. The growing gender digital divide currently prevents women and girls from accessing the digital world equally, limiting their opportunities as economic, social, and political actors. Gender-biased technology affects individual women and contributes to setbacks in the advancement of gender equality and women's empowerment. Hurdles to women's and girls' digital literacy continue to exist, including access and affordability challenges, lack of education, and socio-cultural norms. But we cannot move forward without their creativity, their ideas and inventions.

When well used, the digital space is a great equalizer and enabler. Emerging technologies offer immense opportunities to address development and humanitarian challenges and accelerate the achievement of gender equality and the 2030 Agenda's Sustainable Development Goals (SDGs). They provide unprecedented opportunities for greater access to information, education, skills and open possibilities for increased employment and business opportunities for women and girls. They also contribute greatly to improvements in the well-being, education, health and livelihoods of women and girls.

Leveraging technology allows for building communities, networked movements and strengthening democratic engagement, all of which contributes to equality and justice. The free flow of information via the internet and social media contributes to open debate and an exchange of ideas, two crucial tenets of democracy. Pro-democracy activists rely on open internet access. They utilize apps, social media and other technology to raise awareness, mobilize activists and amplify voices.

While the digital revolution brings immense potential to improve social and economic outcomes for women, it also poses the risk of perpetuating existing patterns of gender inequality. A significant digital gender gap remains, limiting the equitable realization of the benefits of digital transformation across high-, low- and middle-income countries.

Gender inequalities still exist in terms of access to connectivity, digital education, and skills, as well as access to the actual technologies, and women are increasingly at a disadvantage in terms of access to information, digital services, and employment in high-growth sectors such as IT, biotech and engineering.

At the same time, we are witnessing a push back on gender equality – online and offline. Women human rights defenders, across the world, are increasingly targeted with reprisals – including online – with the aim of silencing their voices and stopping them from participating in the public discourse. When women and girls do have access to the internet, they face online violence more often than men. During the COVID-19 pandemic, gender-based violence increased exponentially, including online and ICT-facilitated violence. Many women and girl users of the internet and other ICTs have increasingly experienced threats and other forms of sexual harassment, cyberstalking, and assaults on their privacy.



As the largest annual gathering of policy makers and activists from around the world, focusing on the status of rights and empowerment of all women and girls takes place, at the 67th Commission on the Status of Women (CSW 67) in New York, its priority theme brings a unique opportunity to highlight these gendered impacts of innovation and technology and to identify policy recommendations that will allow for a more inclusive, safe and equitable digital evolution. Women and girls must be supported as technology creators and decision-makers so they can design, develop, and deploy technology that meets their own needs.

Access to technology and innovation is key to civil society movement building and strengthening networks of solidarity. We want movements that are effective, resilient, visible and safe. Building feminist communication strategies using technology and innovation is necessary to this. Civil society activists across the world are using information and communication technologies to support rights agendas and tell their stories. Women are taking advantage of the extraordinary potential of technology to fight even more strongly for social justice and equality.

UN Women is deeply committed to support this activism and to grow and expand new multistakeholder, feminist partnerships to strengthen civic space and women's digital rights. Through Generation Equality and its commitments and through the Action Coalition on Technology and Innovation, UN Women will support new technology parameters that support the rights, participation, inclusion, needs and aspirations of women and girls and peoples of the world. Through the discussions at CSW 67 and in the recommendations and implementation agenda that it puts forward, we have the opportunity for coordinated action to unlock a more equitable world and invest in technology as a public good.

For the first time in CSW history, we also have a great opportunity of having young people participate officially in dialogues with Ministers and other decision-makers during CSW67, opening space for their voices to be heard at the highest level and for their inputs to influence the outcome.

The Commission on the Status of Women is every year deeply enriched by the wide participation of civil society and young people from all over the world. Year on year this cohort has grown, and this year is no exception and stands at several thousands of activists and change makers. It is up to us as international organizations, States, and civil society to harness this energy. Together, we call for collective responsibility, from all stakeholders, to develop bold gender- transformative actions to widen innovation ecosystems, embed transparency and accountability in digital technology and expand inclusive digital economies.

WHAT IS THE CSW?

The Commission on the Status of Women (CSW), a functional commission of the United Nations Economic and Social Council (ECOSOC), is a global policy-making body dedicated exclusively to promoting gender equality and the empowerment of women. The Commission was established by an ECOSOC resolution in 1946 with a mandate to prepare recommendations on promoting women's rights in the political, economic, civil, social and educational fields. The Commission also makes recommendations to the Council on urgent problems requiring immediate attention in the field of women's rights..

The Bureau of the Commission plays a crucial role in facilitating the preparation for, and in ensuring the successful outcome of the annual sessions of the Commission. A lingering global pandemic, climate catastrophes, food insecurity, armed conflict spikes, and rising authoritarianism significantly increased levels of already experienced gender-based violence and harassment (GBVH) at work. As more women turn to digital platforms to work, connect, or engage in civic advocacy, the more inhospitable those spaces have become. In this session, panelists promoted by the National Endowment for Democracy's four core institutes - National Democratic Institute, International Republican Institute, Center for International Private Enterprise, and Solidarity Center - will reframe prevention of low- and high-tech-facilitated GBVH as a non-negotiable for democratic societies, connect women leaders across sectors, and draw on the International Labor Organization Convention 190's expanded GBVH protections as critical in this new "world of work."





AN APP THAT SAVES LIVES

One to One Africa serves last mile communities; rural villages beyond the main tar roads. We empower local women, many of them living with HIV, to become Mentor Mothers, providing comprehensive community health care, including maternal & child health services. We train and then equip them with a mobile device to capture, monitor and track health indicators and a backpack carrying basic medical supplies to provide preventive primary health care.

Already serving a caseload of almost 5000 women and children, our peer-to-peer model has been elevated by the launch of our innovative mHealth app. Our mHealth app empowers rural women to take the lead; Mentor Mothers are guided by assessing and analysing the data we methodically collect on our mHealth app to tackle HIV infection rates, monitor pregnancy and antenatal care and minimise malnutrition.



